Objectives

- To understand the main theoretical debates in public management and public policy analysis
- To provide an overview of the main issues currently alive in debates on public administration reform and social policy
- To acquire the knowledge and have an overview of the skills that are necessary within organizational environments in the field of politics and public management.
- To learn to apply knowledge to the analysis of complex social and political problems
- To learn to apply theoretical and methodological models in order to carry out research in this field

Learning method and Evaluation

Learning is based on the reading and discussion of theoretical and empirical knowledge. The aim is to acquire the capacity to formulate questions and answers. To this end, students will have to be active and autonomous in searching and selecting relevant information, in reading and thinking in order to create a rich and informed dialogue with the lecturer and their peers.

This autonomous effort will be required prior to each session, via reading, essay writing and some cases and exercises. This work will be complemented with seminar discussions and oral presentations, which will help to better understand both theory and practice-based knowledge as well as to question it. Class teaching will combine lectures, seminar discussions on theoretical and empirical knowledge as well as case study and exercise work – always trying to find the applicability of theory to the real world. Teaching will focus on the preparation of essays, exercises and presentations.

Class preparation: materials are uploaded in the course Moodle (Campus Virtual).

Evaluation

Students will be assessed across 6 assignments through the course of the module. Assignments are designed to support and assess your learning through a range of exercises. Assignments are adapted to the requirements and content of sessions led by instructors and will include group work, presentations, online quizzes and case study exercises. All assignments will combine information from the sessions, required readings and some original contribution by the student. To help you plan your time, the deadline for submitting/completing is indicated in the module outline below. The final grade will be the average of the 6 assignments. Blending the values, knowledge and skills of the private, public and third sectors, considerable efforts have been made to improve the efficiency and effectiveness of public policy through quasi-marketisation and welfare pluralism. But what substantive possibilities and risks do these actually present? To answer this question, these sessions will explore the case of payment by results contracts in active labour market policy, and the role of private capital in social impact bonds to better understand the role of private actors and finance in public policy.

Abortion has always been considered a morality policy in countries with strong presence of a state/church cleavage. Over the last decades however, abortion has increasingly been politicized even in countries where abortion was legal and politically non-contentious. In this session we will look at the politics of abortion and the determinants for the different national legal frameworks.

Week 7: 13/11/2025 Who cares? Defining and Regulating Sex Trade

Instructor: Marga León

The aim of this session is to critically analyse the core challenges in regulating prostitution from a multi-level governance perspective. We will deconstruct the foundational adversarial framing of the issue, contrasting the 'sex work' and 'prostitution as violence' paradigms that underpin political and scholarly debate. The session will then map and evaluate the primary regulatory models—from prohibition and abolition to decriminalisation and legalisation. Finally, we will interrogate the limitations of nation-state approaches by examining the necessity for, and challenges of, developing a coherent supranational legal framework to address the inherently transnational nature of the sex industry.

Week 8: 18/11/2025 Beyond asset-based welfare: the return of the rental housing question

Instructor: Lorenzo Vidal

This session examines the role of housing within welfare state regimes, focusing on the limitations of homeownership as a form of asset-based welfare and its implications. As the era of mass homeownership recedes in many countries, the private rental market has resurged, bringing renewed debates over its regulation. At the centre of these debates lies one of the most contested policy instruments: rent price controls.

Week 9: 25/11/2025 Social security policy: street-level bureaucracy and accountability

Instructor: Daniel Edmiston

In these sessions, we will explore how social security policies are shaped and implemented through a network of actors, both *upstream* (policymakers) and *downstream* (service users). We will examine the role of street-level bureaucrats in shaping policy outcomes, and particularly how discretion impact can impact service delivery. Accountability for both policy success and failure will be critically assessed by thinking through acts of commission and omission in public and social policy and the important role of discretion across the policy lifecycle. We will also explore whether social security policies 'work' by drawing on the 'expertise' of individuals actually affected, underlining the real-world impact of bureaucratic actions.

*ASSESSMENT DETAILS: Drawing on the academic literature and policy documentation covered in week 9 of the module, students will work in groups to prepare a presentation in advance of this session. Students will draw on a real-world case study to answer the following questions: what are the risks and opportunities associated with street-level bureaucracy? How does the answer to this question according to different stakeholders in the policymaking process. Students will be assigned to groups in advance to allow coordination of work.

Week 10: 04/12/2025 Poverty and inequality in Europe: policy progress and priorities

Within political and academic debate, the terms 'poverty' and 'inequality' are sometimes used interchangeably when talking about the differential life outcomes and opportunities of individuals and communities. In this session, we will explore how poverty and inequality – as distinctive phenomena – are framed across different European welfare regimes and within EU policy frameworks. We will analyse evidence on poverty trends, highlighting successful anti-poverty interventions across Europe. We will also discuss ongoing legislative agendas aimed at reducing poverty and inequality and identify areas where public reforms could prove most transformative.
